# transferring to foster wales

Foster Wales is the national network of not-for-profit Local Authority fostering services across Wales, and our Wrexham team is your local support network.

We're not your standard fostering agency – we're far more connected.

Choosing us is about choosing people, not profit – as a not-for-profit organisation, all our funding goes directly into the fostering service we provide.

We're dedicated to working as a team with foster carers to help build brighter futures for local children. We help them stay in their familiar local environments, when it's right for them.

## already a foster carer?

As your local authority fostering service we are responsible for all the children and young people in care in Wrexham.

We work closely with the team around the child: children's social workers, independent reviewing officers, childcare support workers, schools, educational psychologists and health, to provide the best possible outcome for the children in our care.

There are so many benefits for children when they are placed with in-house foster carers. If you are currently a foster carer with a private agency this guide will provide all the information you need about the transfer process.

Alternatively, if you are relocating and foster for another local authority, please give us a call for a chat. We can then speak to your current team to determine the right transfer process for you.

## local authority fostering service

Local authority not-for-profit fostering teams are part of the same organisation working alongside the social workers who are responsible for the children.

Legally responsible for children coming into care and usually contacting their own foster families first

Carers are matched with a preferred age range of children, from babies to teenagers.

Caring for children who live and attend school within the county area, helping them to stay in their community.

## independent fostering agency

.com website (usually)

Private, limited, for-profit businesses.
Groups of fostering agencies are often
owned by private equity.

Or not-for-profit charities usually with a .org website.

Rely on the local authorities to contact them about children.

Typically older children, with challenging needs or sibling groups when local authorities are not able to match with their own foster carers.

Cover a wide geographic area

## why transfer to foster wales wrexham

We are part of the local authority's children's services team responsible for providing safe and stable homes for children in need of care.


We have a lot of experience of the transfer process whether you have a child or young person living with you already, or not, and can alleviate any concerns and deal with any issues that might arise.

## Route 1 not currently looking after a child

1. Have a chat with your Foster Wales Wrexham team.

We will talk about why you want to transfer and what you would like to gain from transferring to your local authority.

have made the decision to transfer, you will need to inform your current agency that you have applied to foster with Foster Wales Wrexham and that, once your assessment is completed, you intend to resign from their agency.

4. Once your assessment is completed you will attend our Foster Panel who will make a recommendation on the terms of your approval.

Once you are approved you can give 28 days' notice to your current agency.


You will then meet your assessing social worker, who will be with you throughout your assessment process.

We will carry out a new assessment, and will contact your existing agency to access existing documentation to capture your previous fostering experience and training.

## Route 2 currently caring for a child

1. Following the initial steps of Route 1, once you have informed your agency of your wish to move to Foster Wales Wrexham, they will advise the child's independent reviewing officer of your intention to move.

They will then hold a meeting including everyone involved in the care of the child: yourself, the local authority that placed the child, your current agency, and us.



#### 2 The meeting will:

- Ensure the needs of the child/ren continue to be met and their care plan(s) discussed with us as your new support team.
- Discuss the needs of the child and you as foster carers, and how we will support those needs.
- The circumstances in which Foster Wales Wrexham can place another child or children once your transfer to us is completed.

While all this is going on we will continue with the assessment and approval process.

## frequently asked questions

### Do I have to have a formal assessment to transfer to Foster Wales Wrexham?

Yes, but it should be a faster process than your previous assessment if you can provide us with your original assessment. You will have to attend Preparation to Foster training, and undergo the usual background checks and your assessment will then be presented to our foster panel in the usual way.

#### Do I need experience of fostering to transfer to Foster Wales Wrexham?

If you are an approved foster carer with another local authority or fostering agency, but have not yet fostered a child with them, you can still transfer to us. While we value experienced foster carers and those already caring for children who wish to transfer, we also welcome those who are starting their fostering journey. We understand that the realities of fostering with an agency do not always meet your initial expectations.

At Foster Wales Wrexham it's the skills and experience you bring that matter most. We will ensure the best match for you and your family and provide the necessary local support and training to meet the needs of the children in your care.



#### Can I transfer if I already foster a child from Wrexham local authority?

Yes, you can and we would actively encourage this. Your child is already being supported by us and our childcare team. As the key people in the team around the child working directly with us will enable the other professionals working with the child to work more closely with you and ensure that the child's care plan reflects their needs and work together to build better lives for looked after children .

#### Can I transfer if I already foster a child with another local authority?

Yes, you can. As ever, the main priority is the child's welfare. We will discuss, with you and your local authority, the on-going care plan, explore any potential impact and whether it is in the child's best interest remain in your care when you move to Foster Wales Wrexham. We would wish to keep an open dialogue with you and your current LA, so you should discuss your move with them too.

#### How long will it take to transfer?

We make every effort to approve your transfer as quickly as possible and aim to have you approved within as short a timescale as possible, ideally within 4-6 months.
